#### 1. ANNOUNCEMENT:

The Speedway Riders Association of South Australia, hereafter called the PROMOTER will conduct the Bill's Bits & Bikes South Australian Sidecar Championship for Senior competitors. Support events may include Senior Solo and Sidecar, Flat Track Solo, U16 250cc Solo, U16 125cc Solo, 250cc Sidecar, U16 novice 125cc Solo and PeeWee. The venue is the Gillman Speedway, Wilkins Road, GILLMAN on Saturday 27 February 2021.

#### 2. JURISDICTION:

- 2.1. The abovementioned meeting has been authorised by Motorcycling SA Inc which has issued the Motorcycling Australia Permit Number C21413 and is open to holders of current Motorcycling Australia Senior and Junior competition Licences. Licensees from other Federations are also eligible to compete providing they have clearances from their Federation. The Promoter must obtain an IMN if licensees are from Federations other than Australia and New Zealand.
- 2.2. The meeting will be held in accordance with the current General Competition Rules (GCR's), these Supplementary Regulations, and any final instructions approved by Motorcycling SA Inc.

BY ENTERING THIS MEETING ALL PARTIES AGREE TO COMPLY WITH THESE RULES, REGULATIONS, BY-LAWS AND INSTRUCTIONS.

#### 3. ENTRIES:

- 3.1. Entries open forthwith and close last mail 5.00 p.m. Sunday 14 February 2021. Only entries received 'online' will be accepted. Refer to 'nominations' section on the Gillman website at www.gillmanspeedway.com
- 3.2. In the case of postponement or abandonment of the meeting, all or any part of the entry fee may be retained by the [Club or Promoter whichever is applicable], if such retention is approved by Motorcycling SA Inc. An alternative date will be advised at the earliest convenience.
- 3.3. Entries received on the official entry form are preferred but written confirmation of nomination or an agreed form of nomination between the competitor and the promoter may be accepted.

#### 4. INSURANCE

- 4.1. National Personal Accident Scheme provides basic cover for death and permanent disability.
- 4.2. Ambulance Insurance is compulsory for licensees.
- 4.3 IT IS STRONGLY RECOMMENDED THAT COMPETITORS GIVE CONSIDERATION TO TAKING OUT WEEKLY BENEFITS INSURANCE.

#### 6 ENTRY FEE:

6.1. 1 Championship rider, 1 passenger, 2 mechanic free. All others pay at entry gate.

#### CLASSES OF COMPETITION

As programmed.

TRANSPONDERS WILL BE USED in Senior Solo and Sidecar competition. If transponder is not owned by competitor, one can be hired for a fee of \$25-00 for each meeting. The MyLaps system is used.

#### 8. AWARDS AND PRIZEMONEY:

30-00 per point.  $1^{st}$  500-00,  $2^{nd}$  300-00,  $3^{rd}$  200-00,  $4^{th}$  100-00. Trophies to 3rd. Sashes to 4th.

#### 9. ENTRIES TO CONSTITUTE A CLASS:

#### 10. RACE FORMAT:

Senior Sidecar:

16 riders contesting 20 heats, 'B' Final and 'A' Final. Three highest point scorers progress directly to 'A' Final, with highest point scorer having first choice of gate position, then in descending order. 'B' Final for next four highest pointscorers 4-7, with winner progressing to the Final.

In the event of competitors having equal points to progress to the semi-final, a countback will determine the progressing competitor. Should points still be tied, the event in which those competitors met will determine the progressing competitor.

Support events: As programmed.

#### 11. MACHINES AND RIDERS:

11.1 All machines entered must comply with the current GCRs for speedway competition.

#### 12 GRID POSITIONS:

#### 13 RIDERS' BRIEFING:

A riders' briefing will be held prior to the commencement of racing, which ALL competitors MUST attend.

#### 15 DRUG AND OR ALCOHOL TESTING:

- 15.1 All competitors and officials are advised that as part of the MA and MSA drug education program, drug testing may take place at any competition in accordance with Australian Sports Commission policy as implemented by the Australian Sports Anti-Doping Authority and the Motorcycling SA Drug and Alcohol Policy.
- 15.2 Competitors, officials and other volunteers are advised that Alcohol Breath Testing may take place at this event, in accordance with MA policy.
- 15.2 If any doubts exist over banned substances it is recommended competitors contact the Drugs in Sport Hotline, tel 1800 020 506. When drug testing takes place, the payment of prizemoney may be delayed at the Motorcycling SA Inc. discretion until the results of the tests are known.
- 15.3 For the purposes of drug and alcohol testing, the commencement of the meeting will be deemed to be at the participant's arrival at the venue with the completion of the meeting for the participant being when the participant has vacated the venue.

#### 16. FUEL TESTING/LOGBOOKS/NOISE

- 16.1 Competitors may be instructed to supply a sample of fuel from either their machine fuel tank or from their personal supply at any time during the conduct of the competition.
- 16.2 Log books will be required as per relevant GCR's.
- 16.3 Noise levels will comply with relevant GCR's.

#### 17 CODE OF CONDUCT:

All competitors, officials and parents are reminded of the Motorcycling Australia by-law - CODE OF CONDUCT (as stipulated in the GCRs), which is a guide to appropriate behaviour at all motorcycle race meetings. This CODE OF CONDUCT applies to this Meeting and will be enforced.

Gates Open: 4.00 p.m.

Machine examination: 5.00 to 6.15 p.m.

Riders' briefing: 6.30 p.m.

Competition commences: 7.00 p.m.

COMPETITORS ARE REMINDED THAT COMPETITION COMMENCES AT 7.00 PM SHARP REGARDLESS OF POSITION OF SUN. NO DELAYS WILL BE CONSIDERED. COMPETITORS ARE ADVISED TO TAKE APPROPRIATE MEASURES (IE, DARK LENSES FOR EARLY EVENTS) OR OTHER ACTION TO ALLOW FOR THIS CONDITION.

#### 19 CIRCUIT DESCRIPTION:

The Gillman venue provides a dolomite surface, 12 metres wide in straights, 15 metres wide in bends, approved fencing, concrete pole indicator and fixed overhead lighting.

Length of circuit is 300 metres measured 1 metre from pole line.

Direction of racing: Anti-clockwise for solo, clockwise for sidecar.

#### 20 GST:

The Goods and Services Tax affects the payment of prizemoney. If you do not provide an ABN or declare the sport is a hobby, the Promoter must withhold 48.5% of prizemoney over \$50.00 which is otherwise payable to you. Please tick one of the boxes on the entry form and if appropriate provide your ABN to ensure the full amount of prize money is paid to you.

#### SPECIAL CONDITIONS

- Competitors MUST be in possession of and use an approved 'enviromat' in ALL areas of the venue when their machine(s) have been unloaded. This is in accordance with current GCR's and is NON- NEGOTIABLE. If competitors do not possess 'enviromats' they are available at the Souvenir booth at this venue. DO NOT UNLOAD machinery until you have an 'enviromat' to place correctly under your machine(s). Non compliance with this direction may result in a request to vacate the Pit area.
- 2. Any machines with a 'total loss' oil system MUST have a working, efficient 'CATCH TANK' to eliminate any chance of fuel or oil escaping onto ANY surface of the Pit area.
- 3. Competitors and their support staff are requested to unload machinery in the Pit area as quickly as possible and remove their transporters from the Pit area as soon as is practicable in order to prevent the possibility of oil and other deleterious material dropping on the bitumen and other sensitive areas of the Pit area and causing construction and environmental damage.
- 4. Competitors and their support staff are requested to load their machinery at the conclusion of any meeting as quickly and to vacate the Pit area as soon as practicable for the same reasons as (3) above.
- 5. There is to be NO SMOKING in the Pit Area. Smokers are required to leave the Pit Area should they wish to do so.
- 6. No pushbikes/scooters or similar are permitted in the Pit Area for ANY person.
- 7. Persons under the age of 16 years other than competitors or event participants are NOT permitted to remain in the Pit Area after it is closed prior to meeting commencing.
- 8. Competitors/event participants under 16 years of age must be under the supervision of a parent/guardian/authorised responsible person at all times they remain in the Pit Area during a meeting.
- 9. COVID Plan is in existence relative to the venue. ALL persons are requested to adhere to the requirements pertinent to the Plan.
